A letter from Deb Hauser

President, Advocates for Youth

*The ultimate measure of a man is not where he stands in moments of comfort and convenience, but where he stands at times of challenge and controversy.

Today, our nation faces a new political landscape and an almost incomprehensible threat to so many of the issues and communities we care so deeply about. How we respond will be a measure of our character and our commitment.

2016 was a year of great gains made amidst a tumultuous political and cultural environment. The teen birth rate continued to decline; rates of HIV infection finally leveled off among Black YMSM; SCOTUS took a stand in support of abortion access; the Department of Education issued guidance interpreting Title IX to include discrimination based on gender identity; and President Obama declared Stonewall a national monument.

For our part, Advocates, among other accomplishments, published a groundbreaking, sex education curriculum; spearheaded on-line puberty education; successfully pilot tested the first-ever evidence-based HIV prevention intervention for Black YMSM 16 to 19; assisted 100+ LGBT youth of color to advocate for LGBT-supportive college environments; brought *Know Your IX* into Advocates’ family; and shared more than 1,000 first-person abortion stories.

And, amidst increasingly disturbing rhetoric surrounding the presidential campaign and in the wake of the tragedy at Pulse in Orlando, Advocates and our activists stood firmly in support of immigrant rights, LGBT rights, and racial justice, and firmly against increasing Islamophobia.

But of all of Advocates accomplishments, it is our work to recruit, nurture, train and support young activists that brings us the most pride. Our network of more than 75,000 youth activists, on 1,000 college campuses, extends to all 50 states and 103 countries. **These emerging young leaders represent a progressive future for our nation and our world.**

Caitlyn, who last year won comprehensive sex education for Clark County schools is now fighting to get University of Nevada to declare itself a Sanctuary for undocumented immigrants.

Juan, a 1 in 3 Campaign activist, spent the summer and fall registering his community to vote in the November elections.

Stephen, a young Nigerian activist, spent the year advocating for his right and that of his peers to take leadership roles in the growing LGBT rights movement across the African Continent.

These young people, and so many more just like them, offer us hope for the future. They won’t back down. This generation of youth is dedicated to dismantling oppression and building a more equitable world. Together we can help them make their aspirations a reality, if we are smart enough and brave enough to work alongside them.

“My mother and father had a specific gender role for me, and that was to prepare me to be ‘the man’ for my future wife. They, and society, imposed a very heteronormative perspective; ‘you are a man therefore you are not allowed to clean, wash dishes, or cook.’ With Advocates for Youth I began the process of unlearning this kind of sexist conditioning while also being aware of my privilege. I learned to use my presence as an aid, not a perpetuator, of sexism. Advocates has even helped me expand my knowledge on queer identity. I began my reproductive justice work with a focus on HIV/AIDS, but I have now been able to help fight against abortion stigma and sexism prevalent in my community. I merge queer and abortion work to increase awareness around the importance of intersectionality in reproductive justice. Thanks to Advocates, as a gay Hispanic young man, I am happy to share with my community what I’ve gained in knowledge over the years.”

TOP TEN ACHIEVEMENTS OF 2016

- 1

SPEARHEADED A CULTURAL, POLITICAL, AND MOBILIZATION MOVEMENT AROUND ABORTION STORYTELLING THAT CONTRIBUTED TO A POSITIVE SUPREME COURT RULING.

In 2011, Advocates launched the 1 in 3 Campaign and spent the next five years working to make first-person abortion storytelling a core movement strategy. This year marked a turning point in the fight for abortion access. Staff worked with activists on 100 campuses, produced a second play, and partnered with 14 communities to create cultural advocacy protest art and theater events. First person abortion storytelling played a central role in the field’s strategy for winning *Whole Women’s Health vs Hellerstedt* and factored large in coalition events to shift culture. As a result, the media has increasingly centered real people’s abortion experiences in their coverage, and young people’s support for abortion access has increased.

DISRUPTED BARRIERS TO QUALITY SEXUALITY EDUCATION WITH THE 3RS CURRICULUM.

Advocates published *Rights, Respect, Responsibility: A K-12 Sexuality Education Curriculum* comprised of 81 new, LGBT-inclusive lesson plans that are fully mapped to the *National Sexuality Education Standards* and available free of charge on Advocates’ website. The curriculum has been downloaded more than 4,000 times and has been implemented in some of the nation’s largest school districts with a reach of over three million youth to date. Advocates has trained nearly 1000 educators, helping them to build their skills to teach quality sex education.

BUILT THE LEADERSHIP SKILLS OF HUNDREDS OF YOUTH FROM MARGINALIZED COMMUNITIES.

Each year Advocates for Youth recruits youth of color, LGBT youth, youth from the United States South, and young women as part of a cohort of youth leaders who receive intensive training at a five-day retreat in Washington, D.C., culminating in a day of lobbying on Capitol Hill. This year Advocates launched the Young Women of Color for Reproductive Justice Collective, a network of young women of color from around the country. They will work at the local and national level to decrease sexual health disparities in communities of color, advocate for the inclusion of young women of color in creating solutions to address the impact of reproductive oppression, and empower a new generation of reproductive justice activists within the progressive movement.

CONTRIBUTED TO THE LEVELING OFF OF NEW CASES OF HIV AMONG BLACK YMSM.

For the last decade, Advocates for Youth has worked in communities to ensure that young Black men have access to testing, prevention, and treatment of HIV. This year, Advocates created *Get Your Life*, the first adaptation of an evidence-based intervention for young Black men who have sex with men, and implemented it in six locations in three states. Through its Anti-Homophobia and Transphobia Project, Advocates trained more than 300 clinicians, teachers, activists, and advocates to increase cultural responsiveness and promote integration of youth-adult partnerships into their service provision.

SPEARHEADED A GROUNDBREAKING INITIATIVE TO PRODUCE AND DISSEMINATE AMAZE, A PUBERTY EDUCATION VIDEO SERIES, FOR 10 TO 14 YEAR OLDS.

AMAZE, a collaboration between Advocates, Answer and Youth Tech Health, fills an educational void, providing a website and YouTube channel for 10 to 14 year olds, their parents and educators that hosts an ever-growing series of animated, humorous and age-appropriate sex education videos. Topics to date include puberty, healthy relationships, consent, masturbation, sexual orientation, gender identity and more. The series was an instant sensation, with hundreds of thousands of views in its first month, and is now being adapted for use in Mexico, Colombia, Vietnam, Israel, and South Africa.

LAUNCHED THE PAN AFRICAN LGBTIQ YOUTH INITIATIVE TO RAISE VISIBILITY OF YOUNG PEOPLE’S NEEDS AND PRIORITIES, AND DEMAND SPACE FOR YOUTH LEADERSHIP WITHIN THE LGBTIQ RIGHTS MOVEMENT.

Staff worked with youth activists from the continent to document the youth-specific challenges they face, highlight restrictions that affect their meaningful participation in the global LGBTIQ movement, and prioritize their needs to inform a Pan-African LGBTIQ youth-led movement. The group then used the findings to secure youth participation at LGBTIQ meetings on the continent and to shape the Pan-African LGBTIQ Agenda to include the needs and rights of LGBTIQ youth.

INCREASED YOUTH KNOWLEDGE AND USE OF CONTRACEPTION IN SOUTH CAROLINA.

Advocates completed a 10-year initiative in collaboration with the New Morning Foundation to improve contraceptive use in four communities in South Carolina, contributing to greater than state average declines in teenage birth rates in three of the four communities. According to South Carolina Vital Statistics, over the last decade, the state teen birth rate fell 39 percent, but in Richland County it fell 42.8 percent, in Spartanburg it fell 44 percent, and in Greenville, 43.9 percent.

STARTED A MOVEMENT TO IMPROVE THE EXPERIENCES OF LGBTQ YOUTH OF COLOR ON COLLEGE CAMPUSES IN THE U.S. THROUGH MY STORY OUT LOUD.

Youth activists launched the My Story Out Loud campaign and collected more than 100 stories to raise awareness of the challenges LGBT youth of color face when attending institutes of higher education, and to hold academic institutions accountable for creating open and affirming spaces for marginalized students.

TRAINED AND PROVIDED RESOURCES TO YOUNG PEOPLE SEEKING TO PREVENT SEXUAL ASSAULT AND END RAPE CULTURE ON COLLEGE CAMPUSES.

Know Your IX became a project of Advocates for Youth and staff worked with students on over 100 college campuses to challenge their institutions to address violence and discrimination. In Delaware, staff assisted students to defeat a state bill mandating the reporting of sexual assault to police, and worked with students who fought open carry gun legislation in Florida and Georgia. And, through the Trojan “Consent: Ask For It” campaign, Advocates for Youth provided resources to activists on an additional 100 campuses, reaching 50,000 students with information about consent.

BUILT A MULTI-COUNTRY INITIATIVE TO ADVANCE SCHOOL- AND COMMUNITY-BASED SEXUALITY EDUCATION.

Advocates supported implementation of school and community-based comprehensive sexuality education in multiple countries by providing training, curriculum review, resources and consultation. In addition, staff supported regional efforts in East and Southern Africa in collaboration with UNESCO, including training 96 teachers and reaching nearly 7,000 young people.

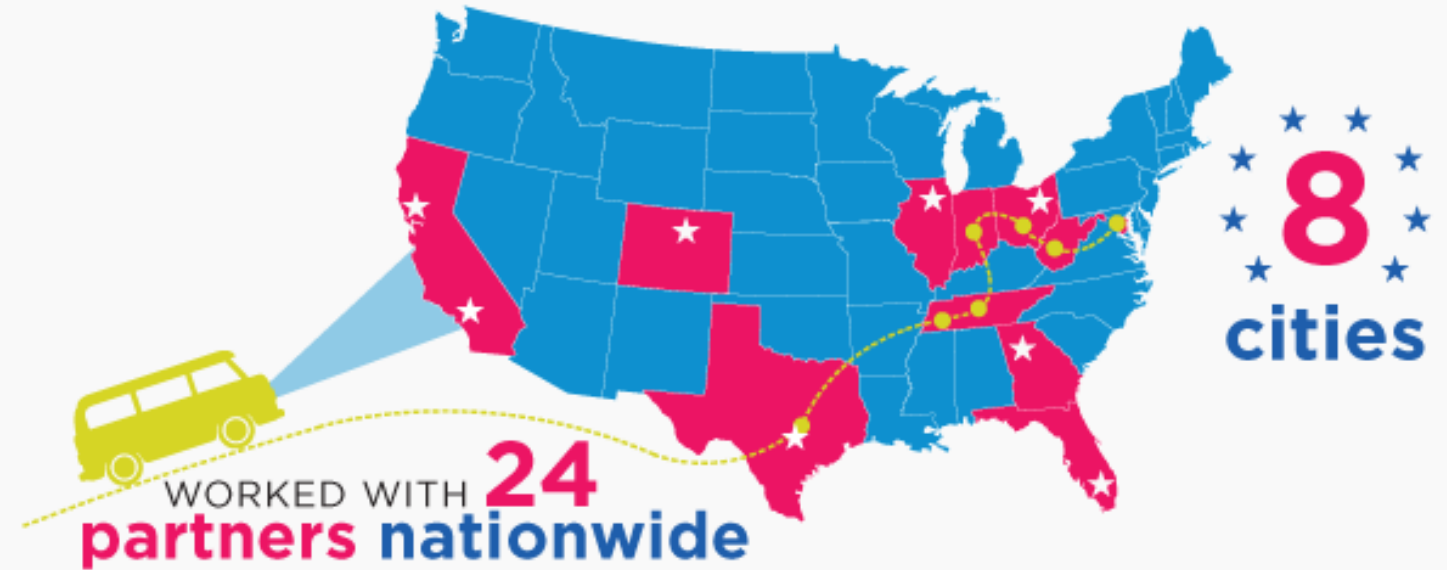

VISION AND VALUES

Advocates for Youth envisions a society in which all young people are valued, respected, and treated with dignity; sexuality is accepted as a healthy part of being human; and youth sexual development is recognized as normal. In such a world, all youth and young adults would be celebrated for who they are and provided with the economic, educational, and social opportunities to reach their full potential. Society would recognize young people’s rights to honest sexual health education and provide confidential and affordable access to culturally appropriate, youth-friendly sexual health education and services, so that all young people would have the opportunity to lead sexually healthy lives and to become sexually healthy adults.

Advocates’ vision is informed by its core values of Rights.Respect. Responsibility.

Advocates believes that:

- Youth have the inalienable right to honest sexual health information; confidential, consensual sexual health services; and equitable opportunities to reach their full potential.
- Youth deserve respect. Valuing young people means authentically involving them in the design, implementation, and evaluation of programs and policies that affect their health and well-being.
- Society has the responsibility to provide young people with all of the tools they need to safeguard their sexual health, and young people have the responsibility to protect themselves.

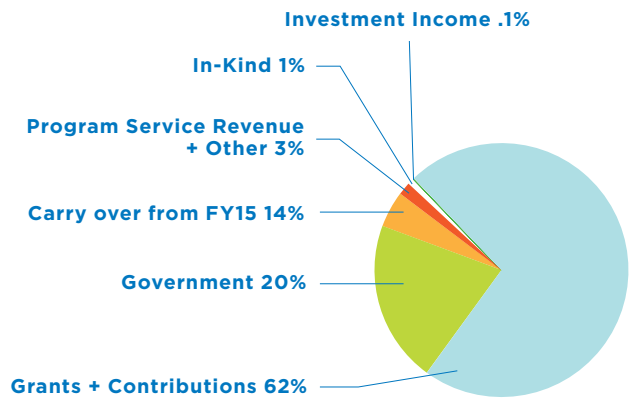

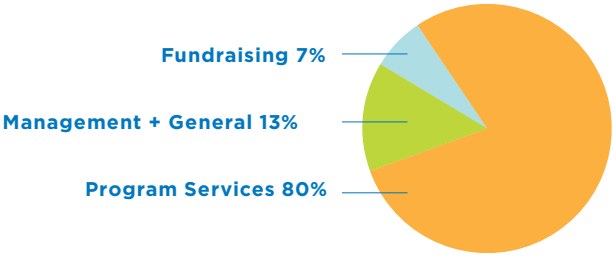
FISCAL YEAR 2016 | APRIL 1, 2015 - MARCH 31, 2016
